An all school lockdown drill was completed at the main building on Thursday, November 17th 2022. Prior to the lockdown drill, a brief announcement was read at 1:30pm. In that announcement, procedures were discussed and then staff were given time to discuss and plan with their students. The lockdown drill was announced at 1:35pm. Stanley Police Chief Lance Weiland was also on site for the lockdown drill.

The middle school classrooms met the expectations of the drill. Lights were off, classroom doors were locked, and students were quiet. I was unable to see any students or staff. The staff did an excellent job of preparing students for the drill.

I was able to see three staff members in the middle school gym. I let them know they were to be in lockdown, and they went to their designated locations. Following the lockdown, I went and had a conversation with them. They were unable to hear the announcement in the kitchen and did not hear it in the gym. I discussed and resolved the issue with Mrs. Schuebel. A separate call will be made to that kitchen.

Drill Remarks:

An all school lockdown drill was completed at the main building on Thursday, November 17th. Prior to the drill, a brief description of why we practice the drill was read to everyone in the building via an intercom announcement. This announcement also gave students valuable information in case they were not in their classroom during the beginning of the drill.

The expectation is that doors are closed and locked, classrooms are dark and quiet with no students visible. When we walked around to check doors, listen for noises and observe to see if students were in view of the window in the door, all rooms met expectations with the exception of one. Students and staff in the gym had a hard time hearing the announcement and started the drill with the first announcement and exited the locker room with the second. They did reenter the locker room a second time during the actual drill and met expectations at that point. Mr. Dusick checked the pool hallway, foyer and kitchen. I checked the 100 hallway, gym, art and shop. Mr. Mahr checked the music/Spanish wing and 200 hallway. All areas were secure; no students or staff were in the hallways.

Kimm Severson conducted a practice drill at Open Doors at 1:00 pm on Wednesday, November 16th. She talked with students about barricading, fleeing, and distracting an intruder. They discussed exit routes and secured themselves in the bathroom as well as various side rooms for the Open Doors version of the all school drill.
